

Codebook for VoteWatch European Parliament and EU Council voting data, Version 1.1

VoteWatch collected two types of data:

- 1) The votes by Members of the European Parliament (MEPs) in all roll-call (recorded) votes between July 2004 and June 2022, as well as information about each of these votes; and
- 2) The votes cast by the member state governments of the EU when voting in the Council of Ministers of the EU (or “EU Council”), between July 2009 and February 2022.

This file gives a basic description of the data in these datafiles.

European Parliament Voting Data

For each session of the European Parliament in this period (EP6 is 2004-2009, EP7 is 2009-2014, EP8 is 2014-2019, and EP9 is 2019-2022), there are two datafiles: one containing the raw roll-call voting data (*EP6_RCVs*, *EP7_RCVs*, *EP8_RCVs*, *EP9_RCVs*); and the other containing information about each of the votes in the roll-call data files (*EP6_Voted docs*, *EP7_Voted docs*, *EP8_Voted docs*, *EP9_Voted docs*).

In the **RCV files**, the columns are as follows:
